**Prison law monitoring in LITHUANIA (extended)** 

# **General Information**

- Title: Monitoring of legal and policy changes on prisons and prisoners' rights in Lithuania
- **Duration**: 10 February 31 December 2025
- Estimated workload: 7-10 days annually, depending on the estimated volume of legal news
- Location: Remote
- Application closing date: 20 January 3 February 2025 EOD (applications get reviewed on a rolling basis, earlier applications received will get preferential treatment)

# **Background information**

The European Prison Litigation Network (EPLN) is a network of 30 European NGOs in 20 European countries that aims to defend and promote the fundamental rights of prisoners across the continent. To this end, we develop our activities in three priority areas: prisoners' access to justice, prisoners' access to health care, and the fight against torture and ill-treatment in prisons and against impunity for perpetrators.

The consultancy is part of the four-year PrisonCivilAct project (2022-2025) funded by the European Union (EU). The project brings together partners from 14 EU countries and Ukraine and aims to strengthen the role of civil society and lawyers in addressing the structural problems of prison systems in Europe and to promote the social rehabilitation of prisoners through more effective and human rights-compliant sentencing mechanisms.

# **Objectives and Deliverables**

The aim of the consultancy is to contribute to a coordinated monitoring of domestic prison legal news in 14 EU countries and Ukraine by providing regular information on the most important legal and policy changes in the field of prisons and prisoners' rights in Lithuania.

Coordination is provided by the EPLN Secretariat.

Throughout the consultancy period, the consultant is expected to submit 4 legal monitoring reports (one per quarter).

All deliverables are to be submitted in English, via email, in Word format, in accordance with the guidelines and deadlines communicated. The consultant will be responsible for quality control of language accuracy. The reports should be sent in a way that allows immediate publication.

## Methodology

Monitoring and research guidelines will be provided by the EPLN Secretariat to the winner of the tender.

The guidelines will include guidance on the scope of legal monitoring and a model report.

# Selection criteria and evaluation process

The applicant can be either a legal entity (NGO, University, Bar association...) or an individual expert.

The applicant should be able to demonstrate:

- Adequate qualification (education and experience background) in a relevant academic field (penal and prison law, human rights law, European law)
- In-depth knowledge of European human rights law, Lithuanian penal and prison law and prisoners' rights
- Knowledge/experience in human rights legal monitoring
- Perfect command of written Lithuanian and English (C1 level)
- Ability to work under strict deadlines
- Ability to guarantee complete confidentiality

Two criteria will be taken into account during the application review process:

- Qualification and previous experience (80% of the total evaluation)
- Overall cost (20% of the total evaluation)

### **Remuneration and costs**

Applicants should provide a detailed breakdown of the estimated costs, including the estimated number of days worked and their standard daily rate (including taxes and other charges). The selected consultant will be required to confirm their rate prior to the conclusion of the contract.

### Application process

Applications should include the following elements, in English language:

- A letter/email describing in a few sentences your motivation and qualifications for the assignment
- The curriculum vitae of the consultant or of the team involved in carrying out the consultancy
- Two examples of similar work carried out previously (with detailed references)
- A total cost estimate

• A brief description of the entity (name, history, mission, expertise)
